**Rules and Regulations for Participation**

1. All camps shall be set-up in designated areas only.
2. No one will be admitted to the camp area that has not gone through registration.
3. No vehicles will be allowed in the camps after 7:00 AM on Saturday.
4. Vendors not doing a period correct interpretation shall be set up in the area specifically designated for modern vendors.
5. Absolutely no digging in permitted. This prohibition includes fire-pits.
6. Parking shall be in designated areas only.
7. Only Federal (Union) uniforms shall be worn by soldiers during the course of the event day(s) except during, just prior to, and after the skirmish.
8. RV's, motorized homes/campers, etc. are restricted from parking in the park proper. It is recommended that parking for such vehicles be pre-arranged with an off-site RV Park.
9. Use of the barracks is restricted as follows:
  - Overnight sleeping is limited to 20 adult re-enactors. No persons under the age of 16 are permitted without adult supervision.
  - Bedding shall be period correct or, removed from the premises no later than 7:30 AM during the event.
  - Absolutely no smoking, use of alcohol, use of matchers or lighters, candles, or any other device with an open flame is allowed inside or within 50 feet of the barracks building.
  - All indoor restroom facilities shall be off limits. People housed in the barracks shall be required to use the portable toilets located outside of the barracks.
  - No food or beverage is allowed inside the barracks.
  - Heel plates are not allowed in the barracks.
  - All modern utilities will be turned off during the event hours.

I have read and understand the above rules and regulations. I understand that failure to adhere to any of them may result in my being required to leave the premises.
